## 1. PARTIES

This Team Training Contract (the "**Contract**") is between **Missoula High Performance, LLC ("MHP")** and the team or organization identified above (the "**Team**"), acting through its authorized representative.

## 2. SERVICES & SCOPE

## 5. ATHLETE ROSTER & GROUP SIZE

The Team will provide MHP with a roster of participating athletes at the start of the Contract. The fee is fixed for the agreed tier; adding athletes beyond the upper bound of the tier requires moving to the next tier (with adjusted pricing). Removing athletes mid-Contract does not reduce the fee.

## 6. LIABILITY WAIVERS

Each athlete (or parent/guardian for athletes under 18) must execute MHP's individual Liability Waiver before their first session. The Team representative will coordinate collection of signed Waivers; MHP will not permit participation without a Waiver on file.

## 7. CANCELLATION & TERMINATION

**Cancellation by Team:** The Team may cancel this Contract with 30 days' written notice. Fees paid for the current and prior service periods are non-refundable. Cancellation effective at the end of the notice period.

**Termination by MHP:** MHP may terminate for non-payment (15+ days late), repeated safety issues, or material breach, with 15 days' written notice and opportunity to cure.

**Pause / freeze:** Force majeure or mutually agreed pause may extend the Contract end date by the equivalent number of weeks, with no refund.

## 8. FORCE MAJEURE

Neither party is liable for failure to perform due to events beyond reasonable control (natural disaster, government order, facility closure, pandemic). The affected party must give prompt written notice and the parties will negotiate in good faith to extend or modify the Contract.

## 9. COACH SUBSTITUTION & CONTINUITY

MHP may use qualified substitute coaches when the lead coach is unavailable. MHP guarantees continuity of programming and methodology across substitutions. Extended absences (3+ consecutive sessions) entitle the Team to a session-by-session credit or pro-rated refund at the Team's option.

## 10. INSURANCE & INDEMNIFICATION

MHP carries general and professional liability insurance and will provide a certificate on request. The Team represents that participating athletes are covered by health insurance (or that the Team or guardians are financially responsible for medical care).

Each party agrees to indemnify the other for claims arising from its own negligence or willful misconduct.

## 11. CONFIDENTIALITY

MHP will keep all athlete health, performance, and personal information confidential. Aggregate, anonymized performance data may be used by MHP for programming research and case studies.

## 12. GOVERNING LAW & DISPUTES

This Contract is governed by the laws of the State of Montana. The parties agree to attempt good-faith mediation in Missoula County before pursuing litigation. Any litigation shall be filed in the courts of Missoula County, Montana.

## 13. ENTIRE CONTRACT

This Contract, together with all individual athlete Liability Waivers, constitutes the entire understanding between the parties. Modifications must be in writing and signed by both parties.
